BACKGROUND:
2-1. On 6 Apr 16, (b) (6) 60 AMW/JA, telephoned (b) (6) to ask who was investigating the incident that occurred at a reserve retirement ceremony on 3 Apr 16. (b) advised that video of the incident had been posted on the internet.
2-2. On 6 Apr 16, (b) (6) reviewed the blotters and discovered there was a dispatch (Exhibit #1) to Bldg 185, at 1608hrs, 911 Response/Disorderly Conduct, that (b) (b) (6) ,(b) (6) and (b) (6) responded to. In summary; (b) (6) , telephoned the ECC requesting assistance as Mr RODRIGUEZ was being unruly during a retirement ceremony at Bldg 185. (b) (6) (b) (6) and (b) (6) were briefed and dispatched. RODRIGUEZ was directed not to enter the facility and then escorted off the installation. A report number was not identified. (b) (6) concluded further investigation would be necessary.
2-3. On 6 Apr 16, (b) (6) reviewed a story titled "Video: Retired SMSgt Forcibly Removed from Retirement Ceremony" posted to J*Q*P John Q. Public on 4 Apr 16 (Exhibit #2).

NARRATIVE:
Unit Commander Notification:
3-1.On 7 Apr 16, (b) (6) contacted (b) (6) and briefed him on the initiation of this investigation concerning an alleged battery that occurred at SMSgt ROBERSON's retirement ceremony.
Other Investigative Activity
3-2. On 6 Apr 16, (b) (6) telephoned SMSgt ROBERSON (b) (6) and requested a statement. ROBERSON confirmed that he had requested RODRIGUEZ conduct the flag ceremony at his retirement and that there wasn't any reason to throw him out. Due to ROBERSON's distance away from Travis AFB, (b) (6) requested ROBERSON email him a detailed statement.
3-3. On 6 Apr 16, (b) (6) telephoned Mr RODRIGUEZ ((209) 765-2708) and requested a statement. (b) (6) also requested to speak with the female that accompanie RODRIGUEZ to the retirement. RODRIGUEZ confirmed he was an invited guest of Mr ROBERSON's and was asked to conduct the Flag Folding Ceremony. Mr RODRIGUEZ believes the incident was the result of personal issues he had with the commander. RODRIGUEZ stated he was assaulted and wanted all personnel charged for the assault. RODRIGUEZ stated he would talk to the female to see if she wanted to make a statement. Due to RODRIGUEZ's distance away from Travis AFB, (b) (6) requested RODRIGUEZ email him a detailed statement.
3-4. On 7 Apr 16, (b) (6) telephoned (b) (6) (b) (6) and requested a statement. (b) (6) was still upset about the incident. (b) stated he had never met RODRIGUEZ and did not know what had happened prior to the ceremony. (b) confirmed ROBERSON told him that RODRIGUEZ was invited and he witnessed RODRIGUE being forcibly removed from the ceremony. (b) agreed to provide a detailed statement via e-mail.
3-5. On 8 Apr 16, (b) (6) received an e-mailed statement from Mr RODRIGUEZ RODRIGUEZ stated in summary, I wish to file formal charges for any and all violation which took place on 03 April 2016 at the 749th AMXS Squadron, building 185, Travis Air Force Base, California. To include but not limited to civil rights violations, assault and battery, defamation, slander, destruction of evidence, falsification of report/s and conspiracy, to start. RODRIGUEZ also confirmed that he was invited by SMSGT Charles ROBERSON torecite a flag folding script for his (ROBERSON's) retirement. RODRIGUEZ also wanted to file assault charges against the Security Forces that responded for telling him that he had to leave. (b) (6) responded to the e-mail and asked for a detailed statement concerning the events leading up to the ceremony, details of the ceremony as well as what had happened in detail after he was escorted out of the ceremony. RODRIGUEZ replied back stating in summary, I was assaulted and battered, I will b seeking legal counsel before I make any additional statements. I believe it is your obligation to recognize that a crime has been committed and the easily identifiable parties be arrested. In my opinion You need to do your job.
(b) (6) attempted to telephone RODRIGUEZ, left a message, and then sent an e-mail with the VWAP attachment, (b) (6) also provided RODRIGUEZ with the

number to the Base Legal office for assistance (Exhibit #3).

- 3-6. On 8 Apr 16, (b) (6) telephoned MSgt ROBERSON and (b) (6) to ascertain the status of their statements. Both stated they would send them soon. 3-7. On 8 Apr 16, (b) (6) received an e-mail from ROBERSON with an attached statement (Exhibit #4). ROBERSON stated the following in summary; On 6 Mar 16, ROBERSON attended a retirement ceremony for (b) (6) . At the time, he watched Mr RODRIGUEZ do a rendition of the Flag Folding ceremony and liked it so he asked Mr RODRIGUEZ to do the same thing at his retirement. Several days later, (b) (6) told him that RODRIGUEZ might not be able to attend and told him to contact (b) (6) . On 8 Mar 16, ROBERSON contacted (b) (6) and was told (b) (6) had banned RODRIGUEZ from the facility. On 29 Mar 16, (b) told ROBERSON that he thought RODRIGUEZ was banned from doing the ceremony and recommended RODRIGUEZ not attend. On 29 Mar 16, ROBERSON told RODRIGUEZ that his leadership did not want him to perform the speech; however, he (ROBERSON) did, and left the decision on doing the speech up to RODRIGUEZ. On 30 also told ROBERSON he did not believe there was a problem with RODRIGUEZ attending the ceremony as a guest but didn't believe he could do the speech. ROBERSON then sent RODRIGUEZ an invitation and had him added to the guest list. On 2 Apr 16, ROBERSON advised RODRIGUEZ that he had a meeting with (b) (6) and (b) (6) . In the meeting (b) (6) and (b) (6) told ROBERSON that RODRIGUEZ could attend as a guest but they preferred that he did not, and that he could not do the speech at the flag folding ceremony. ROBERSON told RODRIGUEZ he would understand if RODRIGUEZ did not want to attend. On 3 Apr 16, (t asked ROBERSON to make sure RODRIGUEZ knew that he (RODRIGUEZ) was not allowed to do the Flag Folding ceremony. ROBERSON again informed (b) (6) RODRIGUEZ, he still wanted him to do the ceremony but left the decision up to him. ROBERSON stated during the ceremony everything went well until the Flag Folding Ceremony. When RODRIGUEZ got up and started to talk (b) (6) ,(b) (6) and (b) (6) ejected him. After the ceremony (b) (6) ROBERSON to speak to the police. The officer was dressed in a blue uniform with small stripes on the arm. The officer asked if RODRIGUEZ had been invited and ROBERSON stated, Absolutely, I invited him as my guest." RODRIGUEZ was then escorted out the gate. 3-8. On 8 Apr 16, (b) sent an e-mail (Exhibit #5) which stated in summary; On 3 Apr 16 he arrived at Bldg 185 and went over the order of the events with the Emcee which he believed was (b) (6) . They practiced the events several times before the start of the ceremony. (b) had never met RODRIGUEZ before and had never met him or seenhim before the ceremony started. (b) related he saw two individuals tryingto fold the flag but they were unfamiliar with the process and were not honor guard. No one else was with them. (b) was not aware of when RODRIGUEZ arrived. Towardthe end of the retirement ceremony the same two airman that were previously practicing marched out with the flag. When they were about finished unfurling the flag a man in a suit stood up. An individual in BDUs stood up, appeared to block RODRIGUEZ and attempted to get him to sit down. Once the airman began folding the flag RODRIGUEZ started talking. As he did a few others approached RODRIGUEZ, grabbed him, and maneuvered him up the ramp toward the back door. met with (b) (6) , and obtained a CD containing a video of the event (Exhibit #6/SN 2113022509642321) and a 3-9. On 11 Apr 16, (b) (6) CD containing all statements leadership had collected concerning the incident (Exhibit #7/SN 2113022509642320). (b) (6) reviewed these exhibits and found the following: (b) (6) provided a memorandum (Exhibit #7A) dated 3 Apr 16 which stated in summary: During the Flag Folding Ceremony RODRIGUEZ stood up behind but in line with the flag detail. An unknown person stood behind RODRIGUEZ and asked him to sit down pointing at this chair. RODRIGUEZ began speaking the words to the ceremony and several other airman (NFI) stood, walked toward RODRIGUEZ, and forcibly escorted him out of the rear door. (b) (6) provided a memo, according to properties the document was created on 3 Apr 16 (Exhibit #7B). (b) (6) stated he told ROBERSON that RODRIGUEZ could not participate in the retirement ceremony and asked ROBERSON to contact RODRIGUEZ and tell him he could not participate. (b) (6) also stated RODRIGUEZ sent (b) (6) an email requesting authorization to enter the 749 AMXS building for a flag folding presentation for a fellow reservist. ROBERSON was asked to contact RODRIGUEZ and lethim know that he could attend the retirement but could not participate. (b) (6) stated the day of the retirement he stood in the hallway waiting to see if RODRIGUEZ was going to show up. Just prior to the event, (b) (6) took his seat and when doing so scanned the audience and did not see RODRIGUEZ. The retirement went as planned until the flag folding ceremony started. When the flag detail was about finished he observed RODRIGUEZ stand up and approach the detail. (b) (6) could see (b) motioning to RODRIGUEZ apparently asking him to take his seat. (b) (6) approached and said something to RODRIGUEZ. RODRIGUEZ ignored both individuals. (b) (6) joined them and helped (b) (6) and (b) physically remove RODRIGUEZ from the auditorium because RODRIGUEZ was not going willingly. (b) (6) waited outside with RODRIGUEZ until Security Forces arrived. While outside, RODRIGUEZ' female companion (NFI) joined him. (b) (6) was surprised that both were smiling and appeared to be happy given the circumstances. When Security Forces arrived, RODRIGUEZ told a responding officer that he had been assaulted. After talking to all parties involved, Security Forces stated RODRIGUEZ would be asked to leave the base and would be escorted off the installation. On 4 Apr 16, (b) (6) spoke to ROBERSON and asked him if he had told RODRIGUEZ that he could not participate in the ceremony. ROBERSON stated he had told RODRIGUEZ that not by choice that he (RODRIGUEZ) would not be allowed to do the flag folding ceremony. ROBERSON stated he could not remember RODRIGUEZ's reaction or what he said. Later, ROBERSON recanted the statement when talking on speaker phone with (b) (6) (349 AMW/PA), (b) (6) ,(b)(6),(b) (6) and himself. ROBERSON also could not remember the conversation he had previously with (b) (6) . (b) (6) provided an e-mail (Exhibit #7C) dated 3 Apr 16 which stated in summary; He attended ROBERSON's retirement and was unaware RODRIGUEZ was there until the slide show, which was before the flag folding, began. RODRIGUEZ remained in his seat when the Airman brought the flag out and began unfolding it. Once it was unfolded, RODRIGUEZ stoop up and took a place near the stage. (b) stood up immediately and began talking to RODRIGUEZ. RODRIGUEZ stood silently as (b) and then others began talking to him. (b) (6) was unable to hear what they were saying and RODRIGUEZ just stood facing the crowd with a thousand yard stare. (b) (6) stated 3-5 airman escorted RODRIGUEZ from the building as he was not responding to any requests to stop his disruption of the ceremony. RODRIGUEZ was held by his arms and was walked backwards as he tried to continue his speech. RODRIGUEZ even tried to grab one of the podiums as he was escorted out. At the conclusion of the ceremony (b) (6) and saw RODRIGUEZ's girlfriend walking toward them. She did not look distressed in any way and (b) (6) describe walked back into the auditorium with (b) (6) her facial expression as smiling or smirking.
- (b) (6) provided a document (Exhibit #7D) dated 3 Apr 16 which stated in summary; (b) (6) had helped plan ROBERSON's retirement ceremony and it was

scheduled for 1500 on 3 Apr 16. (b) (6) also stated that (b) (6) had made a CD that contained music and a voice over which followed the Air Force script. (b) (6), (b) (6), and (b) had planned to ask RODRIGUEZ not to cause an issue. ROBERSON was aware of both these issues. He stated ROBERSON was told RODRIGUEZ could attend, however, he could not participate and if RODRIGUEZ did anything RODRIGUEZ would be escorted out of the building. RODRIGUEZ was not present when the ceremony started and arrived about 5 min into the ceremony. Once RODRIGUEZ sat down, (b) (6) tapped RODRIGUEZ on the shoulder and asked to speak to him. RODRIGUEZ hushed (b) (6) and continued listening to the ceremony. When the flag folding started, (b) (6) realized the music was different. Someone had switched out (b) (6) CD. RODRIGUEZ got up and started his speech. RODRIGUEZ was then escorted out of the building.

(b) 6) provided a document, according to the properties was completed 4 Apr 16 (Exhibit #7E). Thisdocument was without Article 31 warning. The document stated; On April 3 2016 I attended MSgt Roberson's retirement at the request of the retiree. I have recently taken over part of the awards and decorations program and helped to plan, script, coordinate and execute this retirement. As the retirement came to a close and the flag folding portion of the ceremony started I noticed that a gentleman in the front row in a black suit was counting to himself. About halfway through the ceremony the man stood up and aggressively positioned himself next to the airman folding the flag. Not knowing the man's full intention, but certain that he was not part of the script, sequence of events or retirement party, I followed him to the front of the stage. I positioned myself between the crowd and the man in black. I politely asked "Sir, please stop what you are doing." The man refused to acknowledge me as I spoke to him, he just stood there with a glazed look on his face. Again, I said "Sir, you are being disrespectful. Please stop what you're doing and return to your seat." He never once acknowledged my presence or my requests. After the 3rd and 4th unsuccessful attempts to get him to return to his seat other members of the retirement party approached. They informed him that he was being disrespectful and directed him to return to his seat. The man in black blatantly ignored our repeated requests. He just looked ahead as if we weren't there and he could not hear or see us. He then began to speak in a very loud voice. I again asked him "Sir, please stop being disrespectfully as he would allow us) out of the building. The man in blackimmediately started to struggle and began to push me in an effort to get back to the stage all while yelling louder and louder. As he was being escorted out, towardthe rear door of the auditorium, the man in black grabbed onto a pillar and proceeded to scream in my face. I then backed off as I realized

(b) (6) provided an e-mail, dated 4 Apr 16, with a document (Exhibit #7F) which stated (b) (6) attended ROBERSON's ceremony and during the flag folding portion of the ceremony a gentleman in a black suit stood up and began to speak. Several members approached and asked him to leave. He didn't comply and began to shout loudly so several members began to escort him out of the room. There was a struggle as he grabbed a pillar going towards the exit door. (b) (6) treated the situation in the fashion of an active shooter incident and assisted with getting the gentleman out to the exit.

(b) (6) provided a more detailed statement (Exhibit #7G) dated 5 Apr 16. Again, this statement was without Article 31 warning. (b) corroborated his previous statement and went into detail with the events leading up to and the removal of RODRIGUEZ from the building. (b) stated in summary that he told ROBERSON that RODRIGUEZ could not do the flag folding speech and a recording of his voice could not be used either. Furthermore, (b) confirmed RODRIGUEZ was not on the guest list or in the seating chart until 1 Apr 16, two days prior to the ceremony. On 1 Apr 16, (b) telephoned ROBERSON and told ROBERSON of his concern that if RODGRIGUEZ attended RODRIGUEZ might try to do something. (b) told ROBERSON that they had an approved CD that they were going to use so there was no reason to have RODRIGUEZ attend. (b) asked ROBERSON to ask RODRIGUEZ not to attend and explained if RODRIGUEZ did anything RODRIGUEZ would be escorted from the building. ROBERSON told that RODRIGUEZ told him all he wanted was for ROBERSON to have a great ceremony. ROBERSON stated he didn't think anyone would do anything wrong.

(b) (6) provided a memo, according to properties the memo was created on 5 Apr 16 (Exhibit #7H). This statement was completed without Article 31 warning. (b) (6) stated in summary that he told ROBERSON that RODRIGUEZ had been removed from the Honor Guard due to his misconduct in the service that RODRIGUEZ was not welcomed within the unit because of his past military career and that RODRIGUEZ would not be allowed to participate in the retirement ceremony. RODRIGUEZ arrived to the ceremony, he thought after it had started. When RODRIGUEZ stat down, (b) (6) leaned over and told RODRIGUEZ that he was not welcomed and RODRIGUEZ ignored him. After the flag folding ceremony started, RODRIGUEZ stood up and (b) approached RODRIGUEZ asking him to please sit down. (b) (6) got up to assist (b) and asked RODRIGUEZ not to do it and leave, then he told RODRIGUEZ to stop disrespecting SMSgt ROBERSON. When RODRIGUEZ resisted and would not leave or sit down they decided to secure him and escort him out of the building.

(b) (6) provided an e-mail (Exhibit #7I) dated 5 Apr 16 which stated in summary; He attended ROBERSON's retirement. About half way through the retirement ceremony an individual entered through the back door with a friend and sat down in front of him. (b) (6) intercepted him but (b) (6) was unable to hear what was said. During the Flag Ceremony the individual got up, proceeded to say his dialog, and was forcibly removed by (b) (6) and several others. Later, (b) (6) saw where the incident was posted to the internet by (b) (6) .

(b) (6) provided an e-mail (Exhibit #7J) dated 5 Apr 16 which stated in summary; While attending SMSgt ROBERSON's retirement and during the flag folding ceremonyhe saw a man stand up. As the man stood up, one of the NCOs stood in front of him uttering words that he could not hear. It looked as if the NCO was trying to warn him not to recite his speech. After the man began reciting his speech two or three more NCOs proceeded to escort the man out of the building. He continued his speech while grabbing onto the pillars to try to get leverage over the four NCOs. As they finally got him to the exit he grabbed the door to try to stay in the building. After the ceremony I exited the building and saw the man and his wife sitting on the benches outside of the building with a security forces officer talking. The man had a smile that seemed like he planned the whole event and showed no remorse for what had happened.

provided an e-mail (Exhibit #7K) dated 5 Apr 16 which stated in summary; he attended ROBERSON's retirement. About half way through the flag folding ceremony a guy stood up. A Master Sergeant stood up and attempted to talk him out of the speech he appeared eager to do. When the man started speaking the NCO attempted to peacefully guide the man outside but he wasn't complying. Several other higher NCOs helped in removing the man from the room.

provided an e-mail (Exhibit #7L) dated 5 Apr 16 which stated in summary; As Honor Guard he only saw the Section Chiefs and Master Sergeants escort

him out.

(b) (6) provided a Memorandum for Record dated 6 Apr 16 (Exhibit #7M). The memorandum stated in summary; On 6 Mar 16 (b) (6) attended (b) retirement and arrived early. At the ceremony she recognized Mr RODRIGUEZ and he greeted her. She learned that he was at the ceremony to read a script for (b) (6) the flag folding ceremony. On 4 Apr 16, (b) (6) met with (b) (6) and (b) to go over the events of ROBERSON's retirement ceremony. (b) (6) retirement checklist, guest seatingcards, and script. There was no indication RODRIGUEZ was a part of the flag folding ceremony. (b) (6) found RODRIGUEZ's name on the seating chart and asked if they knew RODRIGUEZ could not be a part of the flag folding ceremony. (b) (6) was informed that they had a CD with music and (b) (b) (6) voice over reading the script. (b) (6) told(b)(6) and (b) to seat RODRIGUEZ in the back anticipating enough time to stop him if he stands to participate in the ceremony. Prior to the ceremony (b) (6) went to the auditorium in Bldg 185 to watch practice. Everyone appeared to be there going over their own parts. RODRIGUEZ was not present. When the ceremony started, she did not see RODRIGUEZ seated where he was supposed to be seated. When the music started she learned from that it was the wrong music. Then she observed RODRIGUEZ stand up and approach the flag detail. Two members approached RODRIGUEZ and she departed to (b) (6) call Security Forces. (b) (6) provided a detailed statement (Exhibit #7N) that, according to the properties, was created 6 Apr 16. (b) (6) stated in summary; he was aware RODRIGUEZ had and told ROBERSON that RODRIGUEZ was not allowed to participate as he used a different script from the participated in the retirement ceremony for (b) (6) authorized Air Force script. (b) (6) stated they received an e-mail from (b) (6) that was forwarded from RODRIGUEZ. In the e-mail RODRIGUEZ requested permission to enter the 749 AMXS building for a flag folding presentation for a retirement ceremony on 3 Apr 16. RODRIGUEZ stated in the e-mail that he had been banned by (b) from entering the facility. (b) (6) and (b) (6) contacted (b) and (b) (6) to ensure they knew RODRIGUEZ could attend the ceremony but could not participate. (b) (6) stated he made a CD with the music to "Saving Private Ryan" playing as (b) (6) read the authorized Air Force script for the Flag Folding ceremony. On 3 Apr 16, when the music started (b) (6) recognized that itwas the music RODRIGUEZ usually used in his voiceover; however, there wasnovoiceover. He recognized the music as he had heard it several times in the past at other retirement ceremonies. Further investigation revealed the CD-R (b) (6) had previously recorded had been over written with the new file at 10:15 p.m. on 2 Apr 16. (b) (6) stated their organization has never had RODRIGUEZ's version of the music in their possession. (b) (6) related (b) stood up when RODRIGUEZ did and appeared to gesture to RODRIGUEZ's seat as if he was asking him to sit down. Furthermore, (b) (6) stood up and also said something to RODRIGUEZ. RODRIGUEZ ignored both parties. When RODRIGUEZ began speaking (b) and (b) (6) tried to escort RODRIGUEZ out of the facility. RODRIGUEZ got up and assisted (b) (6) and (b) . RODRIGUEZ grabbed and held onto a pillar while they were escorting him. Lastly, when (b) (6) went resisted and (b) (6) outside he saw RODRIGUEZ and a female friend that accompanied RODRIGUEZ. (b) (6) found it funny that they were smiling and apparently in a happy mood given the circumstances. (Exhibit #8). **(b) (6)** 3-10. On 13 Apr 16, (b) (6) received an e-mail from (b) (6) confirmed that he had invited RODRIGUEZ to conduct the speech during the Flag Folding ceremony at his retirement. He had checked with (b) (6) and at the time no one was aware of any issues involving RODRIGUEZ. At the time of his ceremony, RODRIGUEZ arrived early to practice as well as give guidance to the individuals performing the flag folding and the musical cues they needed to know. At the start of the ceremony, RODRIGUEZ and his fiancé were introduced as honored guests as scripted. Everything went well. ROBERSON was moved and asked (b) (6) he thought RODRIGUEZ would be able to do the same at his ceremony. (b) (6) introduced RODRIGUEZ to ROBERSON. 3-11. On 13 Apr 16, (b) (6) telephoned (b) (6) (b) (6) /Honor Guard to see what the differences were for the Flag Folding Ceremony. Their program is based on Air Force Drill and Ceremony and their publication. They are only authorized to conduct the Air Force scripted ceremony. 3-12. On 13 Apr 16, (b) (6) contacted (b) (6) , Protocol Superintendent, to enquire about Flag Folding Ceremonies. (b) (6) "unofficial" Flag Folding Ceremony. There is only one ceremony and it is directed by the Honor Guard instruction for funerals. Some people opt to have a Flag Folding during his/her retirement for "dramatic effect" for those observing. It is not a normal part of the Retirement Ceremony sequence of events, but an addition just like gift giving. The "official" Retirement Ceremony begins with the entrance of the official party and the National Anthem. It ends with the Air Force Song and the departure of the official party. 3-13. On 14 Apr 16 (b) (6) interviewed (b) (6) (Exhibit #9) (b) (6) clarified information previously obtained (See para 7D). (b) (6) outlined the events that occurred during the retirement, identified (b) (6) as the Emcee and addressed the fact that person(s) unknown had switched the CD. 3-14. On 15 Apr 16, Mr RODRIGUEZ telephone requesting an update. (b) (6) told RODRIGUEZ that the investigation continued. (b) (6) also requested that he reconsider and provide the details that were asked. He stated he doesn't understand why I need it, doesn't trust me, and will only be interviewed by a disinterested third party. 3-15. On 20 Apr 16, (b) (6) to see what she remembered concerning the incident (Exhibit #10). (b) (6) contacted (b) (6) (b) (6) approached RODRIGUEZ from the rear. When he arrived (b) (6) told RODRIGUEZ something to the effect that RODRIGUEZ was not welcomed or was not invited. She was not certain as she was paying attention to the ceremony. 3-16. On 22 Apr 16 (b) (6) contacted (b) (6) . (b) (6) confirmed he had already provided a statement. Because (b) was now identified as a subject, he did not wish to discuss the incident any further without first speaking to an attorney. (b) would contact (b) (6) if it was later determined that he would provide a statement. 3-17. On25 Apr 16, (b) (6) received an e-mail from a person identified only as(b) from the e-mail address of (b) (6) (Exhibit #11). (b) stated, "(b) . Can you tell me why it's been three weeks since the assault at my friends retirement and nothing has been done. You guys are just dragging your heals on the investigation hoping it goes away. If this would have been a female or of color this would be a different investigation. I'm sure there would have already been on the news and at the White House getting an apology from the president. Those involved need to be held accountable as does Travis AFB (b) (6) and the other members that assaulted Oscar need to be punished but no there walking around without a care in the world knowing you guys are not going to do anything. So here's what I'm going to do I'm going to contact all the news outlets with the story. The TRUE STORY not the one you all are making up. I've already talked to Fox News again and the U.K. Is even following the story. The truth is going to be told one way

or the other. Oh how did I get your email I have a inside guy at Travis that feeds me all the information. Have a great day."

(b) out of (b) (6) occupation Air Force, KC10 Crew Chief as of 2005 It was also of interest to note that (b) (6) has the Tweeter account (b) (6)
3-18. On 27 Apr 16, (b) (6) received an e-mail from a person identifying themselves as (b) (6) from the e-mail address (b) (6) (Exhibit #12). (b) stated, "Hey since you won't give (b) the chance to id the guys who assaulted him I'll give you there names since I was sitting on the corner when it happened. (b) (b) (6) . Thesenames have also been posted on the JQP and may also go out to the press."
3-19. On 28 Apr 16, (b) (6) sent an e-mail (Exhibit #13) to (b) (6) ,(b) (6) ,(b) (6) ,(b) (6) , and (b) (6) , AF HQ/A1SA, OPR for AFFAM 34-1202 and AFI 34-1201 to obtain clarification on the spirit and intent of the publications. Specifically:
Can a flag folding ceremony be conducted during a retirement ceremony? If yes, Does it have to be the scripted words per AFI 34-1201 Attachment 4?
(b) (6) highlighted the following references (Exhibit #14) AFPAM 34-1202, IC1, dated 30 Jan 15, para 14.3.4. A retirement ceremony is a military ceremony; other types of tributes such as videos, dramatic flag folding or passing (other than the AF-approved standard, defined in AFI 34-1201, Attachment 4), gift presentations from various groups or individuals should be conducted during informal activities surrounding a retirement ceremony (i.e. reception, dinner, or luncheon) instead of the official ceremony.
AFI 34-1201, dated 25 Jan 13, para 2.15. Flag Folding Ceremony. This paragraph discusses folding the flag of the United States at ceremonies other than military funerals. According to Title 4 United States Code, there is no specific meaning assigned to the folds of the flag. Although there are flag folding ceremony options offered by various national interest groups, these are not official Air Force ceremonies. The Air Force developed a script that provides a historical perspective on the flag. There are no ceremonies in the Air Force requiring a script to be read when the flag is folded. However, when a flag folding ceremony is desired and conducted by Air Force personnel at any location, on or off an installation, this script is the only one that may be used. This includes printing in programs and/or any handouts. See Attachment 4 for this script and a diagram depicting the propermethod for folding the flag of the United States.
3-20. On 2 May 16.(b) (6) interviewed (b) (6) . (b) (6) was identified with his military ID. (b) (6) advisec(b) (6) of his rights IAW Article 31/UCMJ. (b) (6) acknowledged hisrights and declined legal counsel. (b) (6) corroborated the events as described in his previous statement. (b) (6) acknowledged that he walked over to the area where they were having problems with escorting a gentleman out of the auditorium. Given his previous training and the escalation of the situation, (b) (6) assisted by putting his arms around the group, from the back, and pushing them forward. (b) (6) did not want to provide a written statement until he spoke with an attorney.
3-21. On 3 May 16.(b) (6) interviewed (b) (6) . (b) (6) was identified with his military ID. (b) (6) advised (b) (6) of his rights IAW Article 31/UCMJ. (b) (6) acknowledged his rights and declined legal counsel. (b) (6) acknowledged he had previously provided a statement (Exhibit 7H) and confirmed the information previously provided was true and correct (b) (6) added he had approached (b) and RODRIGUEZ in fear of (b) 's safety. RODRIGUEZ was not complying with (b) (6) request and (b) (6) was concerned that the situation may escalate. (b) (6) did touch RODRIGUEZ's arm in an attempt to get RODRIGUEZ to comply with (b) (6) request to sit down or leave. Once (b) (6) stepped in, (b) (6) backed away because he has hip problems and RODRIGUEZ was resisting. (b) (6) accomplished a sworn written statement (Exhibit #15).
3-22. On 4 May 16, (b) (6) interviewed (b) (6) . (b) (6) was identified with his military ID. (b) (6) advised (b) (6) of his rights IAW Article 31/UCMJ. (b) (6) acknowledged his rights and declined legal counsel. stated he was unaware of prior incidents or communications with Mr RODRIGUEZ as he is on a different shift. (b) (6) related he attended ROBERSON's retirement which went real well until the flag folding. When the detailcame out with the flag, an individual stood up and walked to the front near the stage. (b) (6) was unaware of who the person was or what he was doing. (b) approached the individual and appeared to talk with him so (b) (6) assumed the individual was not part of the script. (b) (6) stood up to talk to the "non responsive" individual and then (b) (6) stood. (b) (6) stood up, stopped (b) (6) , and told (b) (6) that he had it. Not knowing what the individual was about to do and seeing the individual pushing against (b) (, stepped in to help escort the gentlemen out of the auditorium. The individual was grabbing walls and pillars on his way to the back door. As they reached the back door, (b) (b) (6) kind of wrapped his arms around everyone and moved them out the door. Once outside (b) (6) went back into the auditorium. A (b) was leaving opposite of everyone else, toward the door where the individual was escorted out. (b) (6) assumed the female was with the individual that was escorted and he found it very strange that she had a smile on her face when she was walking by. (b) (6) provided a sworn written statement (Exhibit #16).
3-23. On 10 May 16, (b) (6) contacted (b) (6) to clarify information within the initial report. (b) (6) did not instruct anyone to ask RODRIGUEZ to sit or be removed when RODRIGUEZ stood up during the ceremony. (b) (6) also stated, as far as he knew from SMSgt ROBERSON, Mr RODRIGUEZ was an uninvited guest. When (b) (6) asked ROBERSON if he had contacted RODRIGUEZ he stated he had. ROBERSON also told (b) (6) that he had uninvited RODRIGUEZ.
2-24. On 10 May 16, (b) (6) provided a statement (Exhibit #17). In summary (b) (6) stated after lunch they practiced in the auditorium 1 or 2 times before the ceremony started. When they first got there and were setting up (b) (6) told them that the CD that had the music for the ceremony had a voice over. During the first practice in the auditorium they found that the music did not have the speech on it. It appeared to be thewrong CD. (b) (6) thought (b) (6) looked for another CD but could not find one and told them that there would be no speech during the music so they had to listen to the music for the ques on when to unfold and fold the flag. They practiced one more time and returned back stage where they waited until the end. While unfolding the flag (b) (6) heard Mr. RODRIGUEZ start his speech, shortly after RODRIGUEZ started he heard what sounded like someone trying to remove Mr. RODRIGUEZ from the auditorium and Mr. RODRIGUEZ refusing to leave. He could not see anything that was happening

because he was facing the other way. They completed the flag folding and returned back stage until the end of the ceremony. They were unaware RODRIGUEZ was going to be part of the ceremony. 2-25. On 11 May 16, (b) (6) contacted(b)(6) and confirmed the flag detail personnel told him that the CD did not have the voice over prior to the ceremony. stated he forgot all about it as he was coordinating other issues with the retirement ceremony.
